



**Articulation Agreement
Between
St. Charles Community College
and
Webster University**



Introduction

This articulation agreement formally recognizes that Webster University, hereinafter referred to as WU, and St. Charles Community College, hereinafter referred to as SCC, are educational institutions with a shared commitment to increasing opportunities for student access to and success in higher education. By clarifying transfer policies and procedures which assure articulation between programs, the institutions seek to assist students in making a seamless transfer from the associate to the baccalaureate degree.

Statement of Purpose

The purpose of this agreement is to facilitate transfer student matriculation from SCC to WU, and to provide a seamless transfer for students who begin study at SCC and transfer to WU for completion of the baccalaureate degree.

Terms & Conditions of Transfer

This agreement shall be governed by the academic policies and procedures of WU and SCC. The evaluation and transfer of earned college credit should be in compliance with WU's guidelines and policies.

Students who enter Webster University with an associate degree from St. Charles Community College, have successfully completed a minimum of 60 earned college-level credits, and meet Webster admission requirements as outlined in the undergraduate catalog shall be accepted to Webster with junior status. Students must meet departmental requirements for acceptance into specific majors.

Webster reserves the right to deny admission or the benefits of this agreement to students who have been suspended or dismissed from any college or university or to those who have been convicted of a felony. Webster may also deny admission or the benefits of this agreement to any applicant who presents other factors in the personal or academic background that the University deems inappropriate, as deemed by the Transfer Admissions Committee.

Admission is not guaranteed for entrance into any specific academic program at WU. Certain degree programs within the Leigh Gerding College of Fine Arts (art, dance, theatre, music) and College of Arts & Sciences (nursing) require additional admission requirements.

Responsibilities of Each Institution

Webster University and St. Charles Community College will:

- Maintain the integrity of their separate programs and enter into this agreement as equal partners.
- Put the needs of the students first by serving students in the best manner possible.
- Work to promote academic success of all students by maintaining quality academic programs and institutional accreditation.
- Provide accurate and timely information to students interested in transfer to WU.
- Publicize this transfer agreement through web and printed materials and conversations with students.

Webster University will:

- Provide SCC staff with WU materials regarding programs, admission, and enrollment.
- Conduct information sessions/workshops for SCC students regarding admissions, financial aid, and registration.
- Host SCC students on campus for tours and personalized appointments.

St. Charles Community College will:

- Provide information about Webster to interested students, faculty, and counselors.
- Provide an opportunity for Webster to present to SCC students at transfer events and/or college fairs.
- Notify WU of significant curricular changes that will impact any transfer guide materials.

Educational Opportunities

In the St. Louis region, Webster University offers courses at four locations: home campus in Webster Groves, WingHaven campus in O'Fallon, Westport campus in Maryland Heights, and the Gateway campus in downtown St. Louis.

The University offers online undergraduate degree completion programs in Data Analytics (BS), Management (BA), Media Communications (BA), Nursing (RN to BSN), and Religion & Global Society (BA).


Webster students have an opportunity to study at any of the Webster University campuses around the world. Students may also choose to study under one of Webster's online degree offerings.


Terms of Agreement


